#### **ACTION ITEMS:**

A. <u>Onondaga County School Bus Photo Violation Monitoring System Agreement</u> "WHEREAS, New York Education Law § 1709(43) provides the authority for the District to enter into an agreement with the County of Onondaga ("County"), for the installation and use of school bus photo violation monitoring systems pursuant to the New York Vehicle and Traffic Law § 1174-a; and

WHEREAS, the County has established a School Bus Photo Violation Monitoring Program ("SBPVMP"), imposing motor vehicle owner liability for the failure of an operator of a motor vehicle to stop for a school bus displaying its red visual warning signals and an extended stop arm; and

WHEREAS, the County and the District seek to enter into an agreement for the District's use of SBPVMP; and

WHEREAS, the Board acknowledges that the purchase, lease, installation, operation, and maintenance, or any other costs associated with such cameras may not be considered an aidable expense for the District; and

WHEREAS, as the sponsor of the SBPVMP, the County is willing to assume all costs for the installation, monitoring, and maintenance of the SBPVMP within the District; and

WHEREAS, the Board of Education has reviewed the proposed agreement with the County, and wishes to approve said agreement;

NOW, THEREFORE, be it resolved as follows:

- 1. The Board of Education hereby approves the agreement with the County of Onondaga for the facilitation of the County's School Bus Photo Violation Monitoring Program.
- 2. The Board authorizes the Superintendent of Schools to execute the intermunicipal agreement in the form approved by legal counsel.
- 3. This resolution shall take effect immediately."

## B. Peaceful Schools Agreement

"WHEREAS, the East Syracuse Minoa Central School District has been awarded the Stronger Connections Grant, which includes investments in mental health and social emotional learning to support students needs; and

WHEREAS, the East Syracuse Minoa Central School District wishes to utilize available Stronger Connection Grant rollover funds to enter into an agreement with Peaceful Schools to provide Multi-Tiered Systems of Support Coordination, Technical Assistance, and Behavior Support Coach professional services;

NOW THEREFORE, BE IT RESOLVED, that the Board of Education, upon the recommendation of the Superintendent, authorizes the Executive Director of School Business Administration to execute an agreement with Peaceful Schools in the amount of \$322,766.40 for a term of February 24, 2025 - June 30, 2026 in order to provide district wide services in support of the Stronger Connections grant to be paid from budget code F 2110.400-00-2425."
