A. Notice of Annual Meeting, Vote Propositions and Election Personnel Appointments

NOTICE OF ANNUAL MEETING

"BE IT RESOLVED by the Board of Education (the Board) of the East Syracuse Minoa Central School District, Onondaga County, New York (the District), as follows: Section 1. That the annual budget hearing will be held on May 12, 2025 at 6:00 p.m. for the purpose of discussing expenditure of funds for the 2025-2026 school year and the budgeting thereof. The hearing is open to the public and will be held at the Central High School located at 6400 Fremont Road, in the Town of Manlius, New York. Any updated information about access and location will be published on the School District's website at https://www.esmschools.org/ when available and questions may also be directed to the District Clerk at 315-434-3004, or kskahen@esmschools.org.

<u>Section 2.</u> That voting upon (i) the 2025-2026 annual school budget; (ii) any additional propositions, and (iii) the election of members of the Board will take place on May 20, 2025 at the High School gymnasium, between the hours of 12:00 noon and 9:00 p.m., and that such voting shall be by voting machine or paper ballots.

<u>Section 3.</u> That the School District Clerk is hereby authorized to publish the legal notices as specified by law and to amend such notice from time to time as, in her discretion, such amendment may be required by law.

Section 4. This resolution shall take effect immediately."

VOTE PROPOSITIONS

"BE IT RESOLVED, by the Board of Education of the East Syracuse Minoa Central School District as follows:

<u>Section 1</u>. The District hereby determines that the acquisition of four (4) full-size school buses with wheelchair lift and two (2) SUV passenger vehicles constitutes a Type II Action pursuant to Parts 617.5(c)(10) and 617.5(c)(31) of the Regulations and as such is not subject to review under SEQRA.

<u>Section 2</u>. The propositions hereinafter set forth are hereby authorized to be submitted for the approval of the qualified voters at the annual vote and election to be conducted on May 20, 2025.

<u>Section 3</u>. The District Clerk is hereby authorized and directed to include as a part of the notice of the annual district meeting and election notice the propositions in substantially the following form:

NOTICE IS HEREBY FURTHER GIVEN THAT, at said Annual Vote and Election to be held on May 20, 2025 the following propositions will be submitted:

Proposition 1: BUDGET

"RESOLVED, that the Board of Education of the East Syracuse Minoa Central School District be and hereby is authorized to expend the sum of \$107,312,000 as general fund appropriation for the school year 2025-2026 and to levy the necessary tax therefor."

Proposition 2: PURCHASE OF SCHOOL BUSES

"Shall the Board of Education of the East Syracuse Minoa Central School District be authorized to purchase four (4) full-size school buses with wheelchair lift; and two (2) SUV passenger vehicles, including necessary furnishings, fixtures and equipment and all other costs incidental thereto, and expend a total sum not to exceed \$1,200,000, which is estimated to be the total maximum cost thereof, and pay for such vehicles by using \$800,000 from the 2016 Bus Purchase Reserve Fund together with the remaining necessary balance not to exceed \$400,000 paid from 2025-2026 budget appropriations."

Proposition 3: EAST SYRACUSE FREE LIBRARY

"Shall the annual appropriation for the East Syracuse Free Library be increased from \$361,036 to \$368,256 and shall the Board of Education of the East Syracuse Minoa Central School District be authorized to collect such sum by a tax levy."

Proposition 4: MINOA FREE LIBRARY

"Shall the annual appropriation for the Minoa Free Library be increased from \$285,000 to \$290,700 and shall the Board of Education of the East Syracuse Minoa Central School District be authorized to collect such sum by a tax levy."

"NOTICE IS FURTHER GIVEN that qualified voters may apply for absentee ballots or early vote ballots. Applications for absentee or early vote ballots may be obtained at the office of the School District Clerk at 407 Fremont Road, East Syracuse, NY. Any such applications must be received by the District Clerk at least seven (7) days before the date of the vote and election if the ballot is to be mailed to the voter, or the day before the vote and election if the ballot is to be delivered personally

to the voter. Absentee or early vote ballots must be received at the District Office by 5:00 PM on May 20, 2025. A list of all persons to whom absentee voters' ballots shall have been issued shall be available for public inspection in the office of the School District clerk during regular office hours each of the five days prior to the election, except Sundays, and shall also be posted at the polling place at the election of members of the Board of Education."

"NOTICE IS FURTHER GIVEN that military voters who are qualified voters of the School District may apply for a military ballot by requesting an application from the District Clerk at 315-434-3004 or kskahen@esmschools.org. For a military voter to be issued a military ballot, the District Clerk must have received a valid ballot application no later than 5:00 pm on April 24, 2025. In a request for a military ballot application or ballot, the military voter may indicate their preference for receiving the application or ballot by mail, facsimile transmission or electronic mail."

Section 4. The Clerk of the School District is hereby authorized and directed in the name and on behalf of the District to do all acts and things necessary, following the advice and counsel of the District's Attorney and the District's Bond Counsel, to comply with all applicable laws, regulations and executive orders relating to the Annual Meeting to be held on May 20, 2025, and to do all other acts as may be necessary, or in the opinion of the District's Attorney and the District's Bond Counsel, desirable or proper to effectuate the purposes of the foregoing Resolution and to cause compliance by the District with all applicable laws, regulations and executive orders relating to the notice of, and procedural steps to be taken in connection with such Annual Meeting.

<u>Section 5</u>. This resolution shall take effect immediately."
