#### **ACTION ITEMS:**

## A. NYSEG Verizon Easement

"WHEREAS, Niagara Mohawk Power Corporation and Verizon New York, Inc. seek a perpetual right-of-way and easement from the East Syracuse - Minoa Central School District, (the "District") to construct, reconstruct, relocate, extend, repair, maintain, operate, inspect, patrol, and abandon or remove communication facilities and affiliated fixtures and appurtenances thereto across 7225 Central Avenue North located in the Town of Manlius, County of Onondaga, State of

New York (the "Parcel") and to renew, replace, add to, or otherwise change the facilities within the easement area for the purpose of providing affiliated services;

WHEREAS, the District seeks to grant said easement; and

WHEREAS, the location does not interfere with the District's educational program, and the property subject to the easement is not required for School District purposes;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Education of the East Syracuse Minoa Central School District as follows:

- 1. The Board of Education determines that the conveyance of a perpetual right-of-way and easement on property located at 7225 Central Avenue North located in the Town of Manlius, County of Onondaga, State of New York to Niagara Mohawk Power Corporation and Verizon New York, Inc. is an Unlisted Action under the regulations of the State Environmental Quality Review Act and designates itself as Lead Agency.
- 2. Upon review of all information required to make a determination, the Board of Education determines that the action will not result in any large or important environmental impacts, and therefore, it is one which will not have a significant impact on the environment and a Negative Declaration will be prepared and filed with the District Clerk.
- 3. The District shall convey an easement for utility purposes in a form to be approved by the District's counsel to Niagara Mohawk Power Corporation and Verizon New York, Inc.
- 4. The officers and employees of the District are authorized to take such steps necessary to complete the transfer and the recording of the easements.
- 5. This resolution shall take effect thirty days from its adoption unless a petition subscribed and acknowledged by at least ten percent of the qualified voters of the District requiring that the question of Easement be submitted to a vote of the qualified voters of the District is filed with the Clerk of the Board within such thirty days in accordance with the provisions of Education Law § 1804(6)(c)."

# B. <u>Village of Minoa Sewer Agreement</u>

"RESOLVED THAT, the Sewer Agreement between the Village of Minoa and the East Syracuse Minoa CSD, to commence on October 1, 2023 and terminate on September 30, 2026, as outlined in the enclosure, be approved."

## C. OCM BOCES Fiber WAN Renewal

"WHEREAS, the Board of Education of the East Syracuse Minoa School District (hereinafter referred to as the District) desires to enter into a five year service agreement with the Onondaga-Cortland-Madison Board of Cooperative Educational Services (hereafter referred to as OCM BOCES) in order for OCM BOCES to furnish certain services to the District pursuant to New York State Education Law 1950(4)(jj), those services being lit fiber for high speed communication services in Co-Ser 601."

"NOW, THEREFORE, IT IS RESOLVED, that the Board of Education of the District agrees to enter into a contract with OCM BOCES for the provision of said services to the District and not exceed in total over the life of this agreement the annual amount of \$59,064.00 and associated CNYRIC charges with such amount to include annual OCM BOCES support costs and applicable taxes and surcharges, and with such support costs and applicable taxes and surcharges included at the current rate and subject to change as established in the OCM BOCES budget or mandated by any federal, state, or local authority."

"This amount may be amended with the approval of both parties. The District will be liable to OCM BOCES for early cancellation or withdrawal from this agreement to the same extent that OCM BOCES is liable to any vendor(s) of these services, including liability for applicable penalties or liquidated damages, and the District will also be liable for costs and expenses, including reasonable attorneys fees and disbursements, incurred by OCM BOCES as a consequence of any such early cancellation or withdrawal. Payments will be made as part of a regular annual OCM BOCES contract for services. Furthermore, this agreement is subject to the approval of the Board of Education of OCM BOCES. This contract will be for a maximum of 60 months commencing on or about September 21, 2023."

# D. OCM BOCES Adult & Continuing Education Program

"RESOLVED THAT, the Board of Education of the East Syracuse Minoa Central School District authorizes the Onondaga-Cortland-Madison Board of Cooperative Education Services to operate Cooperative Adult and Continuing Education programs at no charge to the district; without affecting their right to operate district programs."

"WHEREAS school districts are authorized to provide Adult and Continuing Education programs in a consortium administered by their BOCES, and

WHEREAS the number of enrollees in certain programs in a single school district does not warrant the operation of those programs, and

WHEREAS there is ample evidence that there is a sufficient demand among adults in the supervisory district to support self-sustaining instructional programs,

THEREFORE let it be resolved that the East Syracuse Minoa Central School District authorizes

the Onondaga-Cortland-Madison BOCES to operate a self-sustaining Adult and Continuing Education Comprehensive Program, during the 2023-2024 school year at no charge to the district."

# E. OCM BOCES Annual Cooperative Bidding

"RESOLVED THAT, The East Syracuse Minoa Central School District (hereafter known as "School District") agrees to participate in 2023-2024 (July 1, 2023 - June 30, 2024) municipal cooperative bids for the commodities cooperative listed below as defined in various provisions of New York State General Municipal Law. maximization The of savings bids will be coordinated by the Onondaga-Cortland-Madison BOCES to ensure maximization of savings to each respective participating School District. Furthermore, that Suzanne Slack, Assistant Superintendent for Administration, Onondaga-Cortland-Madison BOCES, be designated to advertise, receive, open and award on behalf of the participating School District said bids and that is the Board of Education of the BOCES reserves the right to reject any or all bids. The School District is not obligated to purchase from the awarded vendors for any bulk products or services."

"Athletic/physical education equipment & supplies, audio visual equipment, automatic external defibrillators (AEDs), computer paper, computers, printers, software, curtain inspection & treatment, custodial supplies & equipment, digital printers & supplies, elevator maintenance & inspection service, fire extinguisher maintenance & inspection service, HVAC maintenance & inspection services, #2 fuel oil, gasoline, kerosene & diesel fuel, medical/nursing supplies & equipment, musical instruments, natural gas/electricity, paper & envelopes, school bus and & automotive parts, scientific & graphing calculators, telecommunications, textbooks, trash liners, and waste/recycling services."
