"RESOLVED THAT, the East Syracuse Minoa Central School District Board of Education nominate <u>Wayne Brownson</u> to the OCM BOCES Board of Education for the term of office from July 1, 2024 to June 30, 2027."

"RESOLVED BY MR. ALBANESE, SECONDED BY MRS. CUSHING THAT, the Action Item A, as recommended by the Superintendent, be approved."

B. Tax Exemption for Persons with Disabilities and Limited-Income

"WHEREAS, Section 459(c) of the Real Property Tax Law authorizes school districts to provide a partial tax exemption from school taxes for certain property owned by one or more persons with disabilities; and

WHEREAS, the Board of Education of the East Syracuse Minoa Central School District previously established this exemption for eligible owners of property within the District who meet the income requirements set forth in Section 459(c) of the Real Property Tax Law; and

WHEREAS, Real Property Tax Law §459(c)(5) was amended in 2022 to allow jurisdictions to increase the income limits for the exemption; and

WHEREAS, Onondaga County, the Town of DeWitt, and the Town of Manlius, (where a majority of the School District taxpayers reside), have increased the income limitation for full exemption to \$50,000; and

WHEREAS, following discussions and recommendations from a Citizens Action Committee, and a public hearing, the Board of Education has determined that it wishes to adopt the same income eligibility levels as other municipalities within the area."

"NOW, THEREFORE, BE IT RESOLVED, that the Persons with Disabilities and Limited-Income Tax Exemption offered by the East Syracuse Minoa Central School District is hereby amended to provide exemptions as set forth in the following schedule:

\$56,600 to \$57,499	10%
\$57,500 to \$58,399	5%

AND, BE IT FURTHER RESOLVED, that eligibility for this exemption and the procedures for administration of this exemption shall be in accordance with New York State law."

Tax Exemption for Senior Citizens

"WHEREAS, Section 467 of the Real Property Tax Law authorizes school districts to provide a partial tax exemption from school taxes for certain property owned by persons 65 years of age or over; and

WHEREAS, the Board of Education of the East Syracuse Minoa Central School District previously established this exemption for eligible owners of property within the District who meet the income requirements set forth in Section 467 of the Real Property Tax Law; and

WHEREAS, Real Property Tax Law §467(3)(a) was amended in 2022 to allow jurisdictions to increase the income limits for the exemption; and

WHEREAS, Onondaga County, the Town of DeWitt, and the Town of Manlius, (where a majority of the School District taxpayers reside), have increased the income limitation for full exemption to \$50,000; and

WHEREAS, following discussions and recommendations from a Citizens Action Committee, and a public hearing, the Board of Education has determined that it wishes to adopt the same income eligibility levels as other municipalities within the area;

NOW, THEREFORE, BE IT RESOLVED, that the Senior Citizen Tax Exemption offered by the East Syracuse Minoa Central School District is hereby amended to provide exemptions as set forth in the following schedule:

Between \$52,000 and \$52,999	35%

Between \$56,600 and \$57,499	10%
Between \$57,500 and \$58,399	5%

C. OCM BOCES Technology Lease Agreement

"WHEREAS, the Board of Education of the East Syracuse Minoa School District desires to enter into up to a 3 year service contract with the Onondaga-Cortland-Madison Board of Cooperative Educational Services (hereafter referred to as OCM BOCES) in order for the Regional Information Center (RIC) to furnish certain services to the District pursuant to Education Law 1950(4)(jj), those services being but not limited to classroom technology and library automation and other instructional technologies in CoSer 562 and/or CoSer 620."

"NOW, THEREFORE, it is RESOLVED, that the Board of Education of the East Syracuse Minoa Central School District agrees to enter into a contract with the OCM BOCES for the provision of said services to the District in total over the life of this agreement not to exceed the principal amount of \$600,000.00 plus related borrowing fees incurred by the OCM BOCES on behalf of the school district, plus yearly Regional Information Center support during the term of this contract. This amount may be amended with the approval of both parties. Payments will be made as part of a regular annual BOCES contract for services. Further, this contract will be finalized by the Superintendent of the school district and is subject to the approval of the Commissioner of Education for both this multi-year service agreement and the OCM BOCES Installment Purchase contract which will be entered into on behalf of the school district at its request. This contract will be for a maximum period of three (3) years commencing on or about March 01, 2024."
