"WHEREAS, the East Syracuse Minoa Central School District has developed an Elementary and Secondary School Emergency Relief (ESSER) Fund American Rescue Plan (ARP) Federal Grant Spending Plan; and

WHEREAS, the ESSER ARP Federal Grant Spending Plan includes investments in Special Education to support meeting the needs of all learners; and

WHEREAS, the East Syracuse Minoa Central School District wishes to enter into an agreement with the New York University Steinhardt School of Culture, Education, and Human Development's Program for Inclusion and Neurodiversity Education (PINE), which will provide online education, remote mentoring, and virtual support to improve educational outcomes not just for neurodiverse students, but for all learners; and

WHEREAS, the PINE program will be implemented at six (6) schools (East Syracuse Elementary, Minoa Elementary, Fremont Elementary, Woodland Elementary, Pine Grove Middle School, and Central High School); and

NOW THEREFORE BE IT RESOLVED THAT, the Board of Education, upon the recommendation of the Superintendent, authorizes the Executive Director of School Business

Administration to execute an agreement within the New York University Steinhardt School of Culture, Education, and Human Development's PINE program for Year 1 in the amount of \$89,100 with a term of July 1, 2022 - June 30, 2023 to be paid from federal ARP grant funding

using budget F 2250.400-00-AR22, and for Year 2 in the amount of \$89,100 with a term of July 1, 2023 - June 30, 2024 to be paid from federal ARP grant funding using budget F2250.400-00-AR23."
