New York State Accountability Status Report - Mr. Hacker reported

The New York State Education Department recently announced the accountability status under the Every Students Succeeds Act (ESSA). Under this new accountability system East Syracuse Elementary, Minoa Elementary, Woodland Elementary and ESM Central High School are all noted as a school "In Good Standings" Pine Grove Middle is designated a "Targeted Support and Improvement School" and ESM as a "Targeted District."

This designation is based on the performance of a certain group of students (approximately 30) on the NY State assessments. In striving for continuous improvement, a comprehensive plan will be developed, aimed at improving student performance in the upcoming months. Mr. Hacker outlined the steps that would be taken at the District and Building level.
