A. <u>Rescind Proposition for East Syracuse Free Library</u>

"WHEREAS, on May 11, 2020, the Board of Education of the East Syracuse Minoa Central School District (the "Board") passed a resolution approving a proposition for the 2020 annual meeting (the "Proposition") which would have placed before qualified voters a request to levy an increased tax to benefit the East Syracuse Free Library (the "Library"), as requested by the Library pursuant to Education Law Section 259(1); and

WHEREAS, on May 1, 2020, the New York State Governor issued Executive Order 202.26, postponing the 2020 annual meeting to June 9, 2020, and requiring school districts to publish a legal notice for the annual meeting no later than May 12, 2020, and a total of two (2) times before June 9, 2020; and

WHEREAS, in accordance with Executive Order 202.26, the School District published its first legal notice for the annual meeting prior to May 12, 2020; and

WHEREAS, on May 13, 2020, the district received a letter dated May 8, 2020 indicating that the Library's Board of Trustees has requested that the Board remove the Proposition from the upcoming ballot for the 2020 annual meeting in light of the implications of the COVID-19 pandemic and surrounding uncertainty; and

WHEREAS, the Board seeks to remove the Proposition from the 2020 annual meeting ballot;

NOW, THEREFORE, be it resolved by the Board of Education of the School District as follows:

Section 1. The Board of Education hereby rescinds its May 11, 2020 resolution approving the inclusion of the Proposition on the ballot at the 2020 annual meeting.

Section 2. The School District Clerk is hereby directed to remove the Proposition from the ballot and the legal notice of the annual School District meeting in accordance with the provisions of the Education Law and to take all other steps to effectuate the intent of this Resolution.
